Service Record: To be qualified, an individual must have given 20 years of service in a called position within the Presbyterian Church (USA), including predecessor organizations, as defined by Monte Vista Grove Homes, and be a member of the Benefit Plan of the PC(USA) Board of Pensions for 20 years or more as confirmed by the Board of Pensions. The qualified individual must be at least 62 years of age before his/her application will be considered.
